Public Comment

Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to two minutes per speaker, unless adjusted by the presiding officer of the Board.

SB 411 Updates:

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering

public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.

Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

- (i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph, to provide public comment until that timed public comment period has elapsed.
- (ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.
- (iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

MOTION

An investment in a public bank is a short term expenditure with long term, long lasting financial benefit. The City and its elected officials have definitively supported on multiple occasions the research needed to see if establishing a public bank in the City of LA is feasible and financially viable; on no less than three occasions over six years Council has voted unanimously to support forward motion (CF 19-1235). There is a precedent set for this financial model by the State of North Dakota - having established a public bank in 1919, and having weathered multiple financial crises due to its ability to leverage assets against itself and be independent from broader markets and federal level changes. Based on study of North Dakota's success and thoughtful analysis of the particular challenges and circumstances of the City, there is potential to create a powerful tool for economic development and budget stability for Los Angeles.

This coming fiscal year in the City of LA has shown the importance of sustainable, flexible funding sources to ensure that the City has the cash needed to maintain core city services and the workforce behind those services. A Public Bank will allow for the holding, and accruing, of flexible money and financing products that can sustain the City in moments of fiscal precarity. It also offers a funding source that can provide the needs of constituents without having to raise their taxes.

Council districts 1, 14, and 13 understand this necessary investment to see the long term benefits of financial independence and are all providing \$15,000 each in discretionary funding to contribute the first tranche of money needed to move forward with the feasibility study.

I THEREFORE MOVE that the City Council INSTRUCT the Chief Legislative Analyst to confirm with the consultants selected to conduct the study, as outlined in CF 19-1235, that the scope of work and timeline provided in the RFP response will be maintained.

I FURTHER MOVE that the City Clerk be directed to place on the Council Agenda for July 1, 2025, or soon thereafter as possible, the following recommendations for adoption:

- Appropriate / transfer \$15,000 from the AB1290 Fund No. 53P, Account No. 281201 (CD 1 Redevelopment Projects Services), \$15,000 from the AB1290 Fund No. 53P, Account No. 281213 (CD 13 Redevelopment Projects Services), and \$15,000 from the AB1290 Fund No. 53P, Account No. 281214 (CD 14 Redevelopment Projects Services) [TOTAL: \$45,000] to the City Administrative Officer Fund No. 100-10, Account No. 3040 (Contractual Services) for the Public Bank Feasibility Study Phase I as outlined in CF 19-1235;
- Authorize the City Administrative Officer to make any corrections, clarifications, or revisions to the above fund transfer instructions, including any new instructions, in order to effectuate the intent of this Motion, and including any corrections and changes to fund or account numbers; said corrections / clarifications / changes may be made orally, electronically or by any other means.

Tuesday, October 14, 2025 Held via Zoom webinar

- 1) Welcome/call to order/Board roll call: Chairperson Joan Jacobs called the meeting to order at 7:02 p.m. The roll call determined that a quorum was present.
- 2) General public comment on non-agenda items that are within the Neighborhood Council's subject matter jurisdiction: There was none.

3) Reports

a) LAPD: Senior Lead Officer Tyson Hamaoka described his patrol area (Figueroa Street to Central Avenue and Imperial Highway to 120th Street). He said that fires along the freeways have increased lately, set by homeless individuals. On October 12, there was a carjacking of an Uber Eats driver at 11714 S. Spring Street. Southeast Detectives are working the case and have a license plate. There have been a lot of petty thefts on the western side of his patrol area. LAPD has assessed the needs for coverage if the Dodgers are part of the World Series playoffs. Senior Leads will be deployed to those patrols during the playoff games for several days.

(Alonzo Williams entered the meeting at 7:10 p.m.)

Majenni Nixon asked about the cause of the AT&T building fire at 16208 S. Vermont Avenue and Officer Hamaoka said that he would contact Senior Lead Officer Robert Martinez who covers that area. Ronald Robinson asked how to handle a stakeholder complaint about the public drinking in front of the Community Market, 814 W. Gardena Blvd., next to the Boys and Girls Club. Officer Hamaoka suggested generating a lot of calls from stakeholders to 311 or texts to 311 about the issue so that for LAPD it shows up as a hot spot that needs special attention.

(Clifford McClain entered the meeting at 7:22 p.m.)

Officer Hamaoka will send an email to the Secretary with his tips for reporting and getting follow up on removing abandoned vehicles and she can then send to the full Board. Requests for service that still do not get taken care of should be sent to the Council office.

(Finesse Simmons entered the meeting at 7:25 p.m.)

He also suggested taking a screen shot of what was submitted via your cell phone or computer as there is no service request number as for 311 requests. If calling in the abandoned vehicle, ask for their Operator Number and note that and time and day of calling in the request. Southeast LAPD has a new Captain, Curtis McIntyre.

- **b)** Council District 15: Rudy Martinez, CD 15 Field Deputy for the Harbor Gateway area, had a family emergency, so was not able to attend.
- c) Other elected officials: Jocelyn Dominguez, Office of Mayor Karen Bass, said that the next Shine LA event in Harbor Gateway North will be held on Sat. November 22 from 9 a.m. to 12 noon in the Athens on the Hill area, in coordination with 28 and Beyond, who provided a lot of volunteers at the Shine LA event on 117th Street near Broadway on July 26. She noted that the FIFA World Cup games will be held in Los Angeles in 2026. The expansion project for the Convention Center has broken ground. This will allow the city of Los Angeles to attract more conventions, thus generating more revenue. Kansas City will host the softball and canoeing events. Highland will provide 300 buses for transportation of Olympic attendees. A weather advisory on potential flash flooding due to the heavy rains was sent out earlier today. At-Large Representative Clifford McClain asked for an update on having

Union Pacific make regular clean ups along their tracks at Broadway and 117th Street. A discussion on Inside Safe will be held on October 21 at 6 p.m. at 6111 Gramercy Place. At-Large Representative Clifford McClain asked for a progress report on having Union Pacific conduct regular clean ups along their tracks, including near 117th Street and Broadway. District 2 Representative Bart Bidlingmeyer said that some Shine LA volunteers wonder why they are needed because it should be the City's responsibility to handle pick up of trash and illegal dumping. Jocelyn said that she agreed, but that one of the key purposes of Shine LA was to develop a volunteer corps that will be able to assist with the many tasks of the Olympics which will take place in less than three years' time. Clifford McClain said that he felt that residents do need to help keep their neighborhoods clean, but that the fines should be increased for illegal dumping and there should be more enforcement.

Kasie Hervey, Constituent Services for 2nd District Supervisor Holly Mitchell, said that the next Racial Justice Learning Exchange will be held on October 25 at 10 a.m. at the MLK Behavioral Health Center, with the topic being "Healing through Indigenous and Native American Perspectives." The County Supervisors have been discussing the Federal shut down and the implications of that on residents being able to afford housing, food, and medical services. There may be an increased demand at local food banks. The Board of Supervisors voted 4-1-0 on an emergency declaration related to ICE actions, with more details on the Board of Supervisors website. There is a Small Business Resiliency Fund for eligible businesses who have been impacted by ICE activities. The Office of Immigrant Affairs can connect impacted residents to needed services.

Jun Aglipay, Field Representative for Assemblymember Mike Gipson, said that a Candlelight Vigil will be held on October 30 from 6-8 p.m. at Wilmington Town Square Park, 105 W. I Street, followed by a mass at St. Peter and Paul Catholic Church. On November 24 from 6-8 p.m. there will be a candlelight vigil at Ted Watkins Park, 1335 E. 103^{rd} Street, followed by a mass at St. Lawrence Catholic church. These are both related to ICE activity. The Assemblymember will hold a Coffee on Thurs. November 20 from 6-7 p.m. at EECI, 555 W. Redondo Beach Blvd., to give a legislative update. Jun has been checking out graffiti along the I-110 freeway and homeless encampments along the freeway on Caltrans properties. Email him for assistance with State issues at moises.aglipay@asm.ca.gov

- d) Department of Neighborhood Empowerment: Helena Doub, Neighborhood Empowerment Advocate for Harbor Gateway North, will be moving to another Department. The new Neighborhood Empowerment Advocate will be Erica Gatica-Doughty, who will start work on October 20.
- e) Report from the Homelessness Liaisons on the September 18 meeting: District 7 Representative Barbara Tyson-Frazier and District 6 Representative Marvin Bell both attended the virtual meeting. Barbara gave the report and commented on the great summary of the role of a Homelessness Liaison which was given by Laurie Jacobs of the Northwest San Pedro area.
- **4) Designation of Rosalie Preston, Secretary, to pick up the HGNNC Board election documents on behalf of the Neighborhood Council**: It was moved by Arvie Powell, seconded by Barbara Tyson-Frazier, and passed 16(Bell, Bidlingmeyer, Cooper-Pace, Guyton, Jackson, Jacobs, Mays, McClain, Nixon, Powell, Preston, Robinson, Simmons, Trejo, Tyson-Frazier, Williams)-0-0 to approve the designation.
- 5) Support for Council File 25-1023 (Modernize Legal Service Delivery Model; Long-term Cost Containment): This motion was made by CD 15 Councilmember Tim McOsker due to recent large expenditures on outside legal counsel and includes recommendations for a multi-year strategy to restructure and modernize the City's legal service delivery model. It was moved by Rosalie Preston, seconded by Marvin Bell, and passed 16(Bell, Bidlingmeyer, Cooper-Pace, Guyton, Jackson, Jacobs, Mays, McClain, Nixon, Powell, Preston, Robinson, Simmons, Trejo, Tyson-Frazier. Williams)-0-0 to take a position of support for the Council File.
- 6) Discussion of Sat. October 18 Board Retreat location this year and in 2026: District 5 Representative Eva Cooper-Pace said that she would like the Board to consider a different location and date for the Board Retreat so that it is held in a location away from regular in-person meeting sites. She also said that she thinks the menu should be something other than cold sandwiches. She suggested holding the Retreat at The Enclave or in a banquet room. Bart Bidlinmeyer said that due to a family

health issue that had come up recently, he would have to miss the Board Retreat if held on October 18. After an informal poll of Board members, it was decided to cancel the Board Retreat that was set to be held on October 18 at 555 W. Redondo Beach Blvd. and re-schedule it, with an Ad Hoc Committee of Eva Cooper-Pace, Marvin Bell, Clifford McClain, Barbara Tyson-Frazier, and Joan Jacobs to work out location details (including permission to meet outside HGNNC boundaries) and menu.

7) Administrative motions

- a) Approval of the August 12, 2025, Board minutes: It was moved by Marvin Bell, seconded by Alonso Williams, and passed 16(Bell, Bidlingmeyer, Cooper-Pace, Guyton, Jackson, Jacobs, Mays, McClain, Nixon, Powell, Preston, Robinson, Simmons, Trejo, Tyson-Frazier, Williams)-0-0 to approve the minutes as submitted.
- **b) Approval of the August 2025 Monthly Expenditure Report:** Treasurer Majenni Nixon screenshared the report and reviewed the expenditures. It was moved by Rosalie Preston, seconded by Frankie Mays, and passed 13-0-0, with three ineligible.
- c) Approval of the September 2025 Monthly Expenditure Report: Treasurer Majenni Nixon reviewed the report. There still has not been notice as to whether the City Council has approved a higher budget amount, so the July MER shows a total budget of \$25,000. The over \$8,000 in rollover funds should be deposited into the HGNNC account in another month. The funds remaining at the end of July were \$20,306.73. It was moved by Rosalie Preston, seconded by Eva Cooper-Pace, and passed 11(Bidlingmeyer, Cooper-Pace, Jackson, Jacobs, Johnson, Mays, Powell, Preston, Nixon, Robinson, Trejo)-0-0, with Bell, Guyton, McClain, ineligible due to incomplete trainings and Simmons due to age, to approve the Expenditure Report.
- d) Approval of up to \$180.00 for 480 HGNNC logo labels for outreach events: It was moved by Eva Cooper-Pace, seconded by Frankie Mays, and passed 11(Bidlingmeyer, Cooper-Pace, Jackson, Jacobs, Johnson, Mays, Powell, Preston, Nixon, Robinson, Trejo)-0-0, with Bell, Guyton, McClain ineligible due to incomplete trainings and Simmons due to age, to approve the support, which will be for the refreshments and candy.

8) Board business/announcements

- a) Reports from Committees: Rosalie Preston, Chair of the Planning and Land Use Committee, said that the City Council's PLUM Committee held their meeting today with the Prologis warehouse issue as item 13 on the agenda, which was the appeal of the City Planning Commission's approval of the EIR. Councilmember Tim McOsker asked that the block wall on the north side of the property be reduced from 18 feet to 14 feet and no mural painted on it. He also said that he had worked with the applicant on the creation of a \$1.2 million community benefit fund to be administered by the California Community Foundation and with a community advisory board to determine how to spend the funds for air pollution mitigations such as air filtration systems.
- b) Brief announcements from Board members: The October 18 Board Retreat is cancelled and will be rescheduled. Rosecrans Recreation Center will hold its Trunk or Treat event on Sat. October 25. The Tuesday October 28 General Membership meeting will be held in person at 555 W. Redondo Beach Blvd. with the new Southeast LAPD Captain McIntyre invited to speak and speakers from the LADWP on the 2025 draft Urban Water Management Plan, with goals for reducing imported water.

- 1) Welcome/call to order/Board roll call: Chairperson Joan Jacobs called the meeting to order at 7:09 p.m. The roll call determined that a quorum was present.
- 2) General public comment on non-agenda items that are within the Neighborhood Council's subject matter jurisdiction: There was none.
- 3) LADWP discusses the 2025 draft Urban Water Management Plan, with goals for reducing imported water through increased conservation measures and alternative sources of water: Benjamin Wong of LADWP Water Resources Division, introduced Kristine Ly, who spoke on the Urban Water Management Plan update, which is required by the State of California to be updated every five years. LADWP is the largest water and power utility in the nation and provides services to 4 million people. After the most serious drought in California history, 1976-77, the Urban Water Management Planning Act was passed by the California legislature requiring water supply planning and reporting throughout the State. The UWMP aggregates multiple planning efforts into one plan. Reliability in water supply is created by balancing projected demand and available supplies over time. The Los Angeles water supply consists of imported water, local ground water, and supplemental supplies (State water project, Colorado River, ground water supplies). The challenges to the water supply are climate change and ground water contamination. Water supply reliability is assessed under four scenarios to create a drought risk assessment. The water shortage contingency plan is a stand-alone plan submitted along with the UWMP. During rainy years and when there is lots of snow, then the excess water is stored at various storage sites. LADWP is working on reducing the use of imported water. Due to water conservation measures promoted by the LADWP, water usage in Los Angeles has decreased even though the population has increased. The deadline for submitting the new UWMP is July 1, 2026. Send comments to uwmp@ladwp.com
- 4) Metro update on the I-105 ExpressLanes project, including night-time closures of Stanford, Avalon, San Pedro, Main Street, Broadway, Figueroa, and Hoover: No speaker from Metro was able to attend. Secretary Rosalie Preston had printed their schedule of the work that is taking place on rebuilding the overpasses for Stanford, Avalon, San Pedro, Main Street, Broadway, Figueroa, and Hoover, which was also included in the Constant Contact newsletter. She noted that the HGNNC has raised the issue of dust suppression related to the project with Ron Macias of Metro and he has said that the contractors performing the work are required to provide dust suppression. However, very little covering of the dirt is taking place. For issues with this project, stakeholders can call (213) 922-6565 and email 105expreksslanes@metro.net

5) Reports

a) Council District 15: Field Deputy Rudy Martinez said that he routinely monitors illegal dumping under the 105 and 110 freeway overpasses. Sanitation used to take 48 hours for pick ups but the time frame is longer now due to lack of staff. RVs on Hoover and El Segundo have been removed using the 72-hour parking limit. There are still RV parking issues at 140th and Vermont Avenue, even with curbs

painted red and "no vehicles over 6' posted signs. RV removals can take a long time to plan and carry out. Rudy is working with Union Pacific on a clean up along 116th Place and also with Caltrans on clean ups of their easements. Estrella north of 135th Street sees constant issues with the homeless. The CD 15 Clean Team used to be able to work on that site twice a month but now only has resources for once a month. New "no litter" or "no dumping signs" are needed along Hoover from El Segundo to Rosecrans as the original signs are now faded. Outreach/Communications Representative Frankie Mays pointed out that the lights under the Main Street over pass are still out, even though Caltrans promised to replace them two years ago. District 6 Representative Marvin Bell commented that Los Angeles is a dumping ground and constantly requires clean up—how can the City be ready for the FIFA World Cup next year and the Olympics in 2028? District 1 Representative Ronald Robinson said that the City needs to provide more enforcement on illegal dumping and higher fines for those who dump. Marvin Bell also raised the issue of sidewalk vendors who block the sidewalk and whose canopies are too low to be easily walked under by taller people.

b) Other elected officials: There were none.

6) Administrative motions

- a) Approval of \$762.10 to Minuteman Press for printing 10,000 October 28 General Membership meeting flyers: There was some discussion as to how effective the flyer deliveries are. Secretary Rosalie Preston said that the flyers result in new stakeholders attending the meetings or calling or emailing the Neighborhood Council. Chair Joan Jacobs pointed out that the Neighborhood Council is required to reach out to stakeholders and this is one of the methods used in that attempt to raise awareness among the 10,000 households. The HGNNC has 1,000 emails on file and 1,000 telephone numbers, so the flyers are another method to reach the other stakeholders. Jeremy Guyton suggested putting a box on the flyer with basic information on how to contact 311. Alonzo Williams suggested trying a different printer based in Carson, who might be cheaper. It was moved by Marvin Bell, seconded by Alonzo Williams, and passed 9-0-0 (Cooper-Pace, Guyton, Jacobs, Mays, Powell, Preston, Robinson, Trejo, Williams), with Bell ineligible, to approve the expenditure.
- b) Approval of \$1,575 to Walking Man for delivery of 10,000 October 28 General Membership meeting flyers: It was moved by Eva Cooper-Pace, seconded by Frankie Mays, and passed 9(Cooper-Pace, Guyton, Jacobs, Mays, Powell, Preston, Robinson, Trejo, Williams)-0-0, with Bell ineligible, to approve the expenditure.

The meeting was adjourned at 8:28 p.m.


